FOOTNOTES:

- (a) If ARC determines they cannot Verify the condition is as stated by Owner (i.e., that this is either an Excepted Tree, a Dead Tree, or an Emergency situation) and that the tree belongs to a different category, ARC Approval conditions for that other category will apply.
- (b) Owners should reference the following sections of the Pine Bay Tree Policy for guidance on tree replacements:
 - a. Section 1.E: Replacement Plan Requirements
 - b. Section 1.F: Tree Replacement Plans
 - c. Section 2: Recommended, Problematic and Banned Trees
- (c) A Certified Arborist Report can only be written by a Certified Arborist who has been and is currently certified by the International Society of Arboriculture (ISA). A certified arborist report must contain the name, signature, and certification number of the arborist issuing the report, and if tree removal is requested, the report must reference one or more Factors for Consideration Impacting Tree Removals & Replacements as listed in the Appendix to the Pine Bay Tree Policy. Arborist reports document the condition of the tree, note issues, damage, or areas of concern, and may provide information about the cause of issues including site conditions, pest or disease threats, or mechanical injury. Recommended actions should be noted, which may include site remediation, increasing vigor through fertilization or injections, pest or disease control, air spading to treat root issues, pruning to eliminate imbalance and unhealthy branches, and removal if remediation is not possible.
- (d) When submitting a Tree Removal Request form for Trees that are categorized in Situation #5 of the Quick Reference Guide, Owners should reference the following sections of the Pine Bay Tree Policy:
